## TERMS OF TRADING AGREEMENT

## Declaration

- The Customer will advise Enhanced Resources in writing, within seven (7) days, of any change in any of the particulars contained in this application.

In the event that Enhanced Resources supply credit to you, then the following terms and conditions shall apply:

- a) Payment for all goods and services shall be made in full 30 days from the date of Invoice.
- b) If you default in payment by the due date then all monies payable to Enhanced Resources for goods and services invoiced prior to the date of default shall immediately become due and payable.
- c) Enhanced Resources shall be entitled to charge interest on all amounts not paid by the due date for payment and the Customer undertakes to pay any such interest charged. Interest shall be calculated at a rate not exceeding 2% per month.
- d) Any expenses, costs or disbursements incurred by Enhanced Resources in recovering any outstanding monies, including debt collection agency and Solicitors fees, shall be paid by the Customer.
- e) Enhanced Resources shall be entitled to terminate without notice any credit arrangement with the Customer in the event of non-compliance in any of the terms and conditions contained herein.
- f) Any subsequent reinstatement of credit arrangements will require payment of the fees applying to a new application.
